GENERAL CONDITIONS / CAMPSITE

1 - The rental is personal and can not be transferred to any other person. The reservation takes effect when we receive the booking form, which must be dated and signed. The signature should be preceded by the words "Lu et approuvé" [Read and approved] in French. The booking form should be sent with a payment of 30% of the total amount. The balance must be paid on your arrival.

2 - Campers may arrive and depart during the week, subject to availability. On the day of arrival, pitches are available from 14.00 and must be occupied before 19.00 hours. Please would you notify us if you are delayed. Pitch bookings are held for 12 hours (without reducing the price of the period booked) but, after 12 hours, the management may re-let the pitch and the deposit will not be refunded. On the day of departure, pitches must be vacated before 11.00 hours.

3 - The charges are based on the dates given on the booking form (in case of late arrival or early departure). If the dates given on this form are changed, no reduction or refund will be made.

4 - Any cancellation must be notified to the campsite.

In case of cancellation :

- more than 30 days prior to arrival, the customer will be reimbursed the entire down payment.
- Less than 30 days prior to arrival, the camping site retains the amounts transferred.

5 - The campsite allocates pitches depending on availability and bookings.

6 - Campers must comply with the campsite regulations. In case of breach of the rules, the campsite gives itself the right to evict.

7 - Parents or those accompanying children must supervise children in all communal areas (washrooms, games room, TV room, outdoor playground, swimming pool and paddling pool). Music is forbidden. The management cannot be held liable in case of accident.

GENERAL CONDITIONS Rented accommodation

1 - The reservation takes effect when we receive the booking form, which must be dated and signed. The signature should be preceded by the words "Lu et approuvé" [Read and approved] in French. The booking form should be sent with the deposit of 30%. The balance of the rental should be paid 4 weeks before arrival.

2 - The owners undertake to provide the accommodation as described and maintain it in good condition. At your arrival, you should verify the inventory and rental accommodation and let us know within one hour after your arrival any anomaly. After this period, it can no longer be taken into account. A deposit of €300 is required by cash on arrival for the accommodation and another deposit of €60 for the cleaning. This deposit will be refunded on departure after the final inspection, less the cost of any repairs that may be necessary. The accommodation should be left perfectly clean. If this is not the case, or if the tenant wishes us to clean the premises, a fixed sum of € 60.00 will be charged for cleaning.

3 - The accommodation is let for a given number of persons. Bookings are made in a given name and may not be transferred without the agreement of the renter. Sheets are required.

4 - Written notification of cancellation must be sent to the owners. In case of cancellation, the following will not be refunded (or will be payable) :

- More than 45 days prior to arrival, a €50 lump sum will be invoiced.
- From 45 days to 15 days, the deposit will not be refunded.
- Less than 15 days prior to arrival, the cost of the stay is totally due.

We would like to draw the tenant's attention to the fact that no cancellation insurance is included in our rates.

5 - Seat cushions, blankets, duvets and mattresses may not be taken outside, i.e. on to the grass or sand. See paragraph 2 for charges for damage to property.

6 - The accommodation can be taken from 3pm in lower season and from 4pm in July and August. And leaving before 10am.

7 - Tenants must comply with the campsite regulations. In case of breach of the rules, the campsite gives itself the right to evict.

8 - Parents or those accompanying children must supervise children in all communal areas (washrooms, games room, TV room, outdoor playground, swimming pool and paddling pool). Music is forbidden. The management cannot be held liable in case of accident.
